








# DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE



### MINIMUM NOISE FIGURE, ASSOCIATED GAIN vs. FREQUENCY






# PACKAGE DIMENSIONS

S02 (UNIT: mm)


(Top View)
