




Fig.3 DC Current Gain vs. Collector Current (I) Fig.4 DC Current Gain vs. Collector Current (II)




Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)

IC/IB = 10,





Fig.7 Base-Emitter Saturation Voltage vs. Collector Current Fig.8 Gain Bandwidth Product vs.



Fig.9 Emitter Input Capacitance vs. Emitter-Base Voltage Collector Output Capacitance vs. Collector-Base Voltage




Fig.10 Safe Operating Area






Fig.11 Safe Operating Area


