

□RETURN LOSS

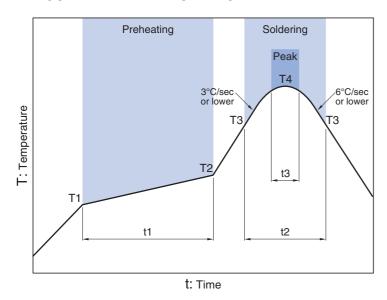
