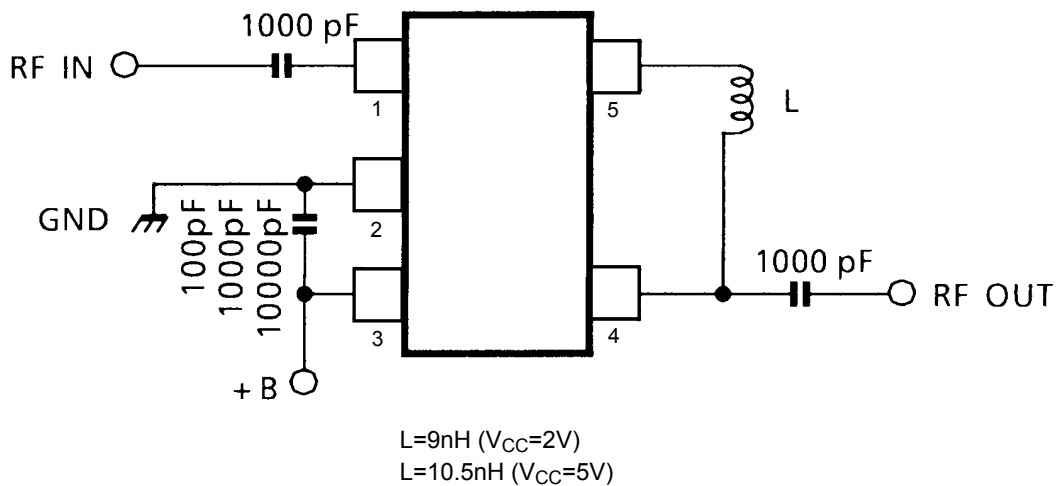

Equivalent Circuit



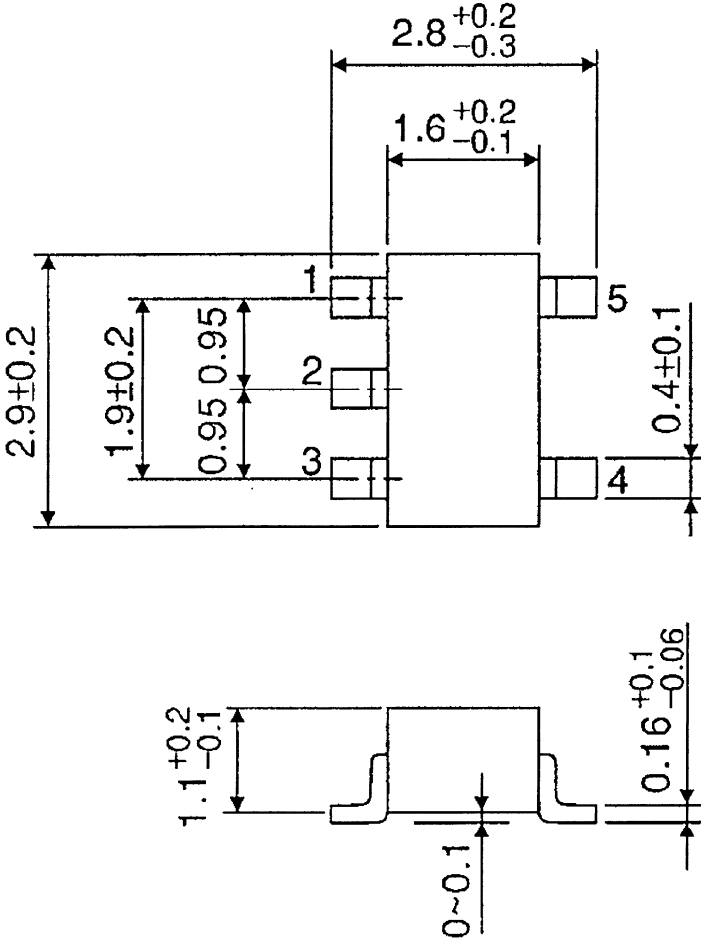
