






Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage





Fig. 4 - Maximum Thermal Impedance Z<sub>thJC</sub> Characteristics

Fig. 5 - Typical Reverse Recovery Time vs.  $dI_F/dt$  (Per Leg)




Fig. 6 - Typical Recovery Current vs. dl<sub>F</sub>/dt (Per Leg)




Fig. 7 - Typical Stored Charge vs. dl<sub>F</sub>/dt (Per Leg)




Fig. 8 - Typical dI<sub>(rec)M</sub>/dt vs. dI<sub>F</sub>/dt (Per Leg)




Fig. 9 - Reverse Recovery Waveform and Definitions


