- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may damage the component. Therefore, we do not recommend using a brush during the PCB cleaning process.

Storage Conditions:


A storage of Würth Elektronik products for longer than 12 months is not recommended. Therefore, all products shall be used within the
